**I agree to the following Rules and Regulations** (exhibitor's Initials: \_\_\_\_\_):

- Except on public show days, only members are allowed to ride on BISC property
- All riders who have not reached their 18<sup>th</sup> birthday must be accompanied by an adult (18 and over) when riding
- Jumping is allowed only with trainer supervision
- For your safety, ASTM/SEI certified helmets and appropriate riding apparel are required for all riders when mounted; apparel may not have attached hoods or strings
- Follow the directions of show staff
- Show staff reserves the right to enforce improper tack and apparel
- Do not use any equipment that is damaged; remove it from arenas and notify a BISC Board member
- Dogs on BISC grounds must be leashed; no dogs in the arenas
- Ride safely and courteously:
  - o Keep your horse under control at all times
  - o Pass left shoulder to left shoulder when approaching another horse from opposite direction
  - o Allow at least 2 horse lengths when following
  - o Give the right of way to horses that are jumping
  - o Halt if a rider falls off a horse, or if a horse becomes out of control

**BAINBRIDGE ISLAND SADDLE CLUB RELEASE, ASSUMPTION OF RISK, WAIVER AND INDEMNIFICATION**

This document waives legal rights. Read it carefully!

I AGREE, in consideration for my participation in Bainbridge Island Saddle Club ("BISC") schooling shows, to the following:

I AGREE, that my participation in BISC schooling shows may include riding, handling, jumping, longeing, walking, grooming, tacking or any other horse related activity whether in the show ring or in a warm up area or anywhere else on the BISC show grounds; and

I AGREE that I choose to participate voluntarily in BISC schooling shows with my horse as a rider, lessee, student, owner, agent, trainer or as a parent or guardian of a junior exhibitor (under the age of 18). I am fully aware and acknowledge that horse sports and this BISC schooling show competition involve inherent dangerous risks of accident, loss and serious bodily injury including broken bones, head injuries, trauma, pain or death ("Harm"); and

I AGREE to release BISC, its officers, directors, members, show sponsors, volunteers, managers, officials, agents, their spouses and heirs ("Released Parties") from all claims for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly from the negligence of the Released Parties.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Released Parties; and

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Released Parties and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at BISC schooling shows; and

I SHALL NOT bring any lawsuit against any of the Released Parties under any legal claim or theory. I make this covenant on behalf of myself, my spouse, my child and/or ward, heirs, administrators, successors, representatives and assigns; and

I AGREE to wear ASTM/SEI-certified protective head gear and proper riding apparel while participating in BISC schooling shows and to abide by all other BISC schooling show rules; and

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release, Assumption of Risk, Waiver and Indemnification.
